I. Introduction

Csodalámpa Óhaj - Sóhaj Kívánságteljesítő Foundation (registered: 1125 Budapest, Alsó - Svábhegyi út 11.; registration number: 01-01-0008929, hereinafter referred to as: "Csodalámpa Foundation" or "Data Controller") the operator of www.csodalampa.hu website ("Website") is committed to the protection of personal data. During its activities, it complies with the rules set out in this privacy policy ("Privacy Policy"), and the relevant data protection law, especially the Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016, ("GDPR"), the Act CXII of 2011 on the right to information self-determination and freedom of information ("Information Act"), and the Act XLVII of 1997 on the processing and protection of health and related personal data ("Eüaktv.").

During each data processing (Privacy Policy Section III/1-5), the employees of Csodalámpa Foundation are entitled to get to know the processed data to the extent that is necessary for the completion of their task.

IV. Data processors

The Csodalámpa Foundation may share the personal data it manages with service providers who process the personal data on behalf of and in accordance with the instructions of the Csodalámpa Foundation, as a so-called data processor:

V. Rights of data subjects

Right of access

The data subject shall have the right to obtain information from the Data Controller as to whether or not personal data concerning him or her are being processed, and, where that is the case, he or she is entitled to access to the personal data and the information being processed. In this context, the data subject has inter alia the right to know what personal data the Data Controller has; on what legal basis; for what purpose; how long they keep it; and to whom, when, under what legislation the Data Controller provided access to his or her personal data or to whom he transferred his or her personal data. Data subject has the right to obtain a copy about his or her personal data processed by the Data Controller.

Right to rectification

The data subject has the right to request Data Controller to correct personal data that is inaccurate or needs correction. In certain cases, the data subject has the right to have inaccurate personal data relating to him or her corrected or completed at his or her request.

Right to erasure

In certain cases, the data subject shall have the right to have his or her personal data deleted at his or her request, and the Data Controller may be obliged to delete such data.

Right to restriction of processing

The data Subject has the right to restrict processing his or her personal data. In this case, the relevant personal data may only be processed for specified purposes.

Right to data portability

In certain cases, the data subject shall have the right to receive the personal data concerning him or her, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller.

In certain cases, in exercising his or her right, the data subject shall have the right to ask for the personal data transmission directly from one controller to another, where technically feasible.

Right to object

In certain circumstances the data subject has the right to object to processing his/her personal data or to ask the Data Controller to stop processing his/her personal data.

If the data subject wishes to exercise the above rights or has any questions related to them, he or she can do so by contacting the Data Controller at the contact details indicated in Section II.

The Data Controller shall respond to the inquiries within shortest time possible, but no later than within one month. The date of receipt of the inquiry does not count into the deadline.

VI. Right of appeal

If the data subject considers that the Data Controller has violated the applicable data protection provisions during the processing of personal data, the data subject is entitled to file a complain at the National Data Protection and Freedom of Information Authority (address: 1055 Budapest, Falk Miksa u. 9-11, postal address: 1363 Budapest, Pf. 9., phone number.: +36 (1) 391-1400, e-mail address: ugyfelszolgalat@naih.hu, websitep: www.naih.hu) or has the opportunity to go to court to protect his or her data. In the latter case, he or she can decide freely whether to turn to the court competent according to his or her residence (permanent address) or place of residence (temporary address) or the controller's registered office.

VII. Data processing for different purposes

In case, Csodalámpa Foundation wishes to carry out further data processing on the collected data for a purpose other than the purpose of their collection, it shall inform the data subjects about this different purpose and about all other relevant information prior to further data processing.

VIII. Amendment of this Privacy Policy

Csodalámpa Foundation is entitled to amend the information set out in this document in case of a change in the legal environment or in the data processing activities. The date of this document is indicated at the end of the document. Please ensure that you review this document from time to time in order to have up-to-date information regarding the processing of your personal information.
